**ADMINISTRATIVE SUMMARY**

Team V was assigned the responsibility of investigating the events, which transpired in the Columbine High School library on April 20, 1999. In order to accomplish that task, Team V was required to conduct detailed interviews with surviving victims and witnesses. In conjunction with the victim/witness interviews, Team V utilized the 911 tape, physical evidence collected at the scene, ballistic reports, medical reports and autopsy reports to determine the sequence of events as they occurred in the library. In addition, Team V consulted with the Jefferson County Coroner and various pathologists to assist in determining the suspects' actions while in the library.

Team V was comprised of six investigators from various agencies. The investigators are identified as Detective R. Boatright, Arvada Police Department (team leader), Detective Diane Obbema, Jefferson County Sheriff's Office, Special Agent John Elvig, Federal Bureau of Investigation, Investigator Jim Burkhalter, Jefferson County District Attorney's Office, Investigator Mike Gallagher, Jefferson County District Attorney's Office and Detective Brice Moomaw, Arapahoe County Sheriff's Office. Detectives Boatright and Obbema along with Special Agent Elvig conducted all interviews with surviving library victims and witnesses. Team V determined there were a total of 56 people present in the library at the time the suspects entered. Of the 56 people present, four were faculty/staff (all female), while the remaining 52 individuals were students. In terms of the 52 students, 24 were male, while 28 were female. Students were of various grades and ranged in age from 15 to 18.

Based on the totality of the investigation, only two suspects were identified as being responsible for injuring or killing those present in the library. The two suspects were identified as Eric Harris and Dylan Klebold. There were no discrepancies regarding that issue. In respect to those present in the library, 14 received injuries of varying degrees while 10 were murdered. The injured were identified as follows:

1. Brian Anderson (treated and released) - shot by Harris (actually injured by west doors prior to entering the library).
2. Jennifer Doyle (hospitalized) - shot by Klebold.
3. Steven Eubanks (treated and released) - shot by Harris.
4. Makai Hall (hospitalized) - shot by Klebold.
5. Patrick Ireland (hospitalized) - shot by Klebold.
6. Mark Kintgen (hospitalized) - shot by Klebold.
7. Lisa Kreutz (hospitalized) - shot by both Klebold and Harris.
8. Patricia Nielsen (treated and released) - shot by Harris (actually injured by west doors prior to entering the library).
9. Nicole Nowlen (hospitalized) - shot by Harris.
10. Kacey Reugsegger (hospitalized) - shot by Harris.
11. Jeanna Park (hospitalized) - shot by Harris.
12. Valeen Schnurr (hospitalized) - shot by Klebold.

13. Danny Steepleton (hospitalized) - shot by Klebold.
14. Evan Todd (hospitalized) - shot by Harris.

To summarize the above information, Eric Harris was responsible for injuring seven people by himself while Dylan Klebold injured six people. Dylan Klebold and Eric Harris were both responsible for injuring one of the individuals.

The deceased were identified as follows:

1. Cassie Bernall - shot by Harris.
2. Steven Curnow - shot by Harris.
3. Corey DePooter - shot by Klebold and Harris.
4. Kelly Fleming - shot by Harris.
5. Matthew Kechter - shot by Klebold.
6. Daniel Mauser - shot by Harris.
7. Isaiah Shoels - shot by Harris.
8. John Tomlin - shot by both Klebold and Harris.
9. Lauren Townsend - shot by both Klebold and Harris.
10. Kyle Velasquez - shot by Klebold.

In summary, Eric Harris was responsible for killing five students, while Dylan Klebold killed two. Together Eric Harris and Dylan Klebold killed an additional three students.

#### **INVESTIGATION DOCUMENTATION**

Team V prepared individual detailed reports related to all interviews conducted. Each of those interviews were summarized in a standardized format for quick reference of specific information. All victim/witness interviews were compared to the physical evidence, ballistic reports, medical reports and autopsy reports for consistency where applicable. After analyzing the above investigative materials, an event summary was prepared describing each significant occurrence while the suspects occupied the library. The event summary is supported by 47 individual event diagrams. Various other diagrams were also prepared to identify each individual's location at the time of this incident while other diagrams were utilized to identify the location of physical evidence.

#### **COMMON VICTIM/WITNESS PERCEPTIONS DURING THE INCIDENT**

(Not contained in the summaries.)

1. Initially heard popping sounds which did not arouse any concern (some student thought they were hearing construction noises).
2. During the initial phase of this incident believed the suspects were engaging in a senior prank.
3. The belief they were actually hiding at the point the suspects entered the library.
4. The inability to estimate the number of gunshots during the course of the incident.
5. Inability to distinguish between the gunshots and explosions.
6. Distortion of time.
7. The belief the suspects were enjoying themselves during the incident.

8. Impaired observations or recall at the point the suspects came within close proximity of their location.
9. For those who were injured (even slightly), the belief they were the last one shot (impaired recall after being injured).
10. The belief playing dead would discourage additional violence.
11. The belief they were one of the last people to leave the library (most students failed to provide assistance to anyone when leaving the library).
12. Many of victims/witnesses were able to recall various details of the incident but had difficulty recalling the events in chronological order.
13. It was evident the media had an impact on witness' statements. Those problems were rectified during the interviews.

### **SUMMARY OF EVENTS OCCURRING IN THE LIBRARY**

On 04/20/99 at approximately 1120 hours, witnesses in the Columbine High School library began to hear what was described as popping noises coming from the northwest outside area of the school. A short time later witnesses described hearing what they now believed were gunshots and explosions inside the school. Some of the witnesses described hearing those sounds emanating from the commons area, in addition to directly outside the library. During that time frame, both Eric Harris and Dylan Klebold are seen in the hall directly outside the library. Eric Harris is subsequently seen in the hall outside the library throwing a lit device (resembling "dynamite") in a southerly direction. Moments later there is an explosion in the hall directly outside the library.

At approximately 1132 hours Eric Harris enters the library and he is seen firing two shotgun rounds in a westerly direction with a pump action shotgun (pellets). Flying wood splinters injures Evan Todd, who is hiding behind a copier stand.

Both Eric Harris and Dylan Klebold are then described entering the library and moving in a westerly direction. Dylan Klebold is subsequently seen shooting a double barrel shotgun (pellets) towards the north computer table as he moves west past the main counter of the library. (The investigation disclosed Kyle Velasquez was shot twice with shotgun pellets while seated at the north computer table.)

Eric Harris and Dylan Klebold are next seen setting down backpacks on the southeast corner of the south computer table. Both suspects are then seen walking west between the north and south computer tables.

Witnesses reported Dylan Klebold stopped at the west end of the computer tables while Eric Harris continued around and then began walking south. After arriving on the south side of the computer tables, Eric Harris got down on his left knee and began shooting out the west library windows. According to witnesses, Dylan Klebold subsequently positioned himself east of Eric Harris and ducked down. Witnesses reported Klebold subsequently fired a weapon in the direction of the west windows.

Dylan Klebold is next seen dropping his black trench coat just to the north side of table #18. During that same time frame, Eric Harris is seen shooting Steven Curnow with a pump action

shotgun (slug). Eric Harris is then seen shooting Kacey Reugsegger with the same pump action shotgun (slug).

According to witnesses, Eric Harris then walked to the south side of table #19 where he slapped the table top twice with his left hand and states, "Peek-a-boo." Eric Harris then points the pump action shotgun under table #19 (held in his right hand) and shoots Cassie Bernall (pellets). After shooting Cassie Bernall, Eric Harris turned to Bree Pasquale and asked her if she wanted to die. Bree Pasquale begged for her life during which time she observed blood began to flow from Eric Harris' nose.

Dylan Klebold is next described firing a shotgun in a southerly direction at table #15 hitting Daniel Steepleton and Makai Hall with pellet rounds. As Patrick Ireland attempts to administer first aid to Hall, he is shot with a second shotgun round (pellets).

Witnesses next described Isaiah Shoels as he was scooting backwards to the east while under table #16. Dylan Klebold subsequently moves to the east side of table #16 and is seen grabbing Isaiah Shoels in an effort to pull him from underneath the table. During the same time frame Eric Harris moves towards table #16 (from the west) and fires the pump action shotgun (slug) shooting Shoels. Klebold is then observed firing a double barrel shotgun under table #16 from the east side, shooting Kechter with a slug round.

While standing to the west side of table #16, Eric Harris is seen throwing a device referred to as a "cricket" in a southerly direction. The device rolled under table #15 making contact with Daniel Steepleton's body. The device is retrieved by Makai Hall and thrown to the south, where it explodes. Around that same time frame witnesses describe seeing smoke rising from the abdominal area of Matthew Kechter, who was located under table #16. (Note: this is the area where Harris was standing when he threw the "cricket" and there is a clear match strike mark on top of table #16.)

Witnesses next describe Eric Harris as he moves south in the library to the west bookshelves where he jumps up on the shelves and begins shaking them back and forth swearing. Eric Harris then walks between the bookshelves (moving in an easterly direction) where witnesses lose sight of him. Witnesses did report hearing books being shot in the area near the west set of bookshelves shortly after Eric Harris walked into that area.

At the same time witnesses explained seeing Dylan Klebold walking on the north side of the library (south of the main counter) moving in an easterly direction. Dylan Klebold continues moving east, stopping near the entrance to the library (north of the display case). Dylan Klebold then fires a Tech 9 into the display case. Witnesses reported Dylan Klebold then moved back around the display case and fired one double barrel shotgun round (pellets) under table #1 hitting Mark Kintgen. Dylan Klebold then stepped east towards table #2 and fired one double barrel shotgun round (pellets) under that same table, hitting both Valeen Schnurr and Lisa Kreutz. Klebold then continued walking south along the west side of table #2, firing multiple rounds (rapid fashion) with the Tech 9 under that same table, hitting Townsend.

Witnesses subsequently see Eric Harris entering the east section of the library (near table #3) from a pathway between the bookshelves. Dylan Klebold subsequently moves west of table #3

near where Eric Harris is standing, after which one of the suspects looked under that same table and states, "Pathetic."

Witnesses next describe both Eric Harris and Dylan Klebold moving to the south of table #5 where it is reported they begin reloading. It is during this time frame one of the suspects begins taunting Valeen Schnurr regarding her belief in God.

Eric Harris is next seen stepping east towards table #6 and pointing the pump action shotgun under that table firing twice (pellets) hitting both Nicole Nowlen and John Tomlin. At approximately the same time Dylan Klebold moves south/east past table #6 standing near John Tomlin (now lying on the east side of table #6) where he then shoots the forenamed four times with the Tech 9.

Eric Harris is next seen moving northeast of table #6, where he shoots Kelly Fleming once with a pump action shotgun (pellets). Once Eric Harris has repositioned himself to the east side of table #4, he then again fires the pump action shotgun under table #2, hitting Lauren Townsend, Jeanna Park and Lisa Kreutz with pellets. Eric Harris subsequently walks to the south library windows and begins damaging the blinds as he looks out into the south parking lot and comments about the police.

Witnesses report Eric Harris and Dylan Klebold then passed through the east side bookshelves in the center section where another reloading process took place at table #13. During that time Eric Harris was seen walking north through the center section to the south computer table where he gained access to the blue backpack reportedly containing ammunition. Eric Harris then returned to an area near table #11. While at that location Eric Harris asked a student under table #11 to identify himself. The student identified himself as John Savage. Eric Harris then moved north of table #11 as Dylan Klebold made contact with John Savage. Dylan Klebold eventually told John Savage to leave the library, which he does.

While standing north of table #11, Eric Harris then shot Daniel Mauser twice (who was located under table #9) with a high point carbine rifle.

Eric Harris and Dylan Klebold then moved south in the library towards table #14. Dylan Klebold then begins firing under table #14 with his Tech 9, hitting Corey DePooter. Eric Harris then begins firing with the high point carbine rifle under the same table, hitting Corey DePooter and Jennifer Doyle. (Note: A fourth 9 mm. round was fired under table #14 hitting Austin Eubanks. The origin of that round cannot be determined.)

Witnesses reported Dylan Klebold and Eric Harris then moved north in the center section of the library and are seen together as they pass by the east side of table #7. Dylan Klebold and Eric Harris then proceed to the southeast corner of the far south computer table. Eric Harris is then seen throwing a device with an orange liquid (southerly direction) in the west section of the library. There was no sound associated with that device being thrown.

Witnesses reported Dylan Klebold then walked around behind the main counter from the west while Eric Harris walked around the counter from the east. At that point Dylan Klebold confronts and threatens Evan Todd, who is now hiding behind the main counter. The investigation revealed Dylan Klebold turned away from Evan Todd and fired a 9 mm. round

back into the "kitchen" area of the library, striking a television. Dylan Klebold and Eric Harris next discussed leaving the library and going to the "commons." Prior to leaving the library, Dylan Klebold slams a chair down on a computer terminal (located on the main counter). Dylan Klebold and Eric Harris subsequently leave the library at approximately 1139 hours. (Note: From the point the suspects entered the library until the time they left was approximately 7 1/2 minutes.)

Most victims and witnesses begin to leave the library, exiting out the north door. A short time later Patricia Nielsen crawls into the break room ("kitchen") and hides in a cupboard. Carol Weld and Lois Keen remain hidden in the television studio. Peggy Dodd was hiding in the periodicals room. All the above named remained in the library until they were evacuated by SWAT. Note: John Ireland laid near table #15 seriously injured and later climbed out a west window. Lisa Kreutz laid seriously injured under table #2 and was evacuated by SWAT.

Team V did not conduct an investigation related to the suspects' activities after leaving the library. Additionally, Team V did not conduct any investigation into the deaths of Eric Harris or Dylan Klebold.

- Event #1:** Klebold is seen walking south past the library window. Observed by Schnurr (LY9).
- Event #2:** Klebold is seen standing outside the library window (hallway area) with a weapon. Observed by Kreutz (LY10), Park (LY11) and Nowlen (LY12).
- Event #3:** Harris is seen standing in the hall outside the library throwing a lit device (resembling “dynamite”) in a southerly direction. Moments later there’s an explosion in the hall directly outside the library. Observed by Todd (LY2).
- Event #4:** As Harris enters the library he is seen firing two gunshot rounds in a westerly direction with a pump action shotgun (pellets). Todd, who is hiding behind the copier stand, is injured by flying wood splinters. Observed by Todd (LY2), Welsh (LG33), and Lapp (LG31).
- Event #5:** Both Harris and Klebold are seen entering the library and moving in a westerly direction. Observed by Schnurr (LY9), Kintgen (LY8), Lagos (LG20), Todd (LY2), Eubanks (LY14), Jacobson (LG19), Holiday (LG22), Wyant (LG7), and Johnson (LG16).
- Event #6:** Klebold is seen shooting the double barrel shotgun (pellets) towards the north computer table as he moves west past the main counter in the library. Observed by Savage (LG25), Houy (LG29), Hall (LY6), and Welsh (LG33). The investigation disclosed Velasquez was shot twice with shotgun pellets while seated at the north computer table.
- Event #7:** Klebold and Harris are seen setting down backpacks on the south computer table. Observed by Steepleton (LY5), Greenwood (LG11), Wyant (LG7) and Welsh (LG33).
- Event #8:** Klebold and Harris are seen walking west between the north and south computer tables. Observed by Pasquale (LG10), Johnson (LG16), Steepleton (LY5), Hall (LY6), and Fair (LG9).

- Event #9:** Klebold stops at the west end of the computer tables while Harris continues and begins walking south. After arriving on the south side of the computer tables, Harris gets down on his left knee and begins shooting out the west library windows. Klebold subsequently positions himself east of Harris and ducks down. Klebold subsequently fires out the west window and then turns south firing his shotgun at table #15. Steepleton, Hall and Ireland are hit with pellet rounds. Observed by Pasquale (LG10), Johnson (LG16), Steepleton (LY5), Hall (LY6), Welsh (LG33), and Greenwood (LG11).
- Event #10:** Klebold is seen dropping his black trench coat on the north side of table #18. Observed by Ruegsegger (LY3) and Johnson (LG16).
- Event #11:** Harris is seen shooting Curnow with the pump action shotgun (slug). Observed by Welsh (LG33), Ruegsegger (LY3), and Johnson (LG16).
- Event #12:** Harris is seen shooting Ruegsegger with a pump action shotgun (slug). Observed by Greenwood (LG11), Welsh (LG33), Ruegsegger (LY3), Johnson (LG16), Pasquale (LG10), and Stair (LG6).
- Event #13:** Harris walks to the south side of table #19, slaps the table top twice with his left hand and states, "Peek a boo." Harris then points the pump action shotgun under table #19 (held in his right hand) and shoots Bernal (pellets). Observed by Pasquale (LG10), Kirkland (LG13), Cohn (LG12), Wyant (LG7), and Schnurr (LY9).
- Event #14:** After shooting Bernal, Harris turns to Pasquale and asks her if she wants to die. Pasquale observes blood begin to flow from Harris' nose. Observed by Pasquale (LG10), Wyant (LG7), Scott (LG15), Johnson (LG16), Hall (LY6), and Cohn (LG12).
- Event #15:** Klebold is seen firing a shotgun (pellets) back at table #15 hitting Ireland as he attempts to administer first aid to Hall. Observed by Steepleton (LY5), Hall (LY6), Kirkland (LG13), Pasquale (LG10), and Ireland (LY7).
- Event #16:** Shoels is observed scooting backwards to the east while under table #16. Klebold moves to the east side of table #16 and is seen grabbing Shoels in an effort to pull him from under the table. Observed by Scott (LG15) and Park (LG14).
- Event #17:** Harris moves toward table #16 (from the west) and fires the pump action shotgun (slug) shooting Shoels. Observed by Pasquale (LG10), and Salmon (LG8).

- Event #18:** Klebold is observed firing a double barrel shotgun under table #16 from the east side, shooting Kechter with a slug. Observed by Park (LG14).
- Event #19:** While standing to the west of table #16, Harris is seen throwing a device referred to as a "Cricket" in a southerly direction. The device rolled under table #15 making contact with Steepleton's body. The device is retrieved by Hall and thrown in a southerly direction where it explodes south of table #15. Observed by Steepleton (LY5), Hall (LY6), Pasquale (LG10), and Greenwood (LG11).
- Event #20:** Smoke is seen raising from the abdominal area of Kechter under table #16. Note: This is the area that Harris was standing when he threw the "cricket" and there is a clear match strike mark on top of table #16. Observed by Salmon (LG8), Fair (LG9), and Scott (LG15).
- Event #21:** Harris moves south to the west bookshelves where he jumps on the shelves and begins shaking them back and forth. Harris then walks between the bookshelves moving in an easterly direction. Observed by Pasquale (LG10).
- Event #22:** Harris walks north between the west bookshelves. He fires shots southward at the bookshelves (pellets). Observed by Parker (LG27), Doyle, (LY13), Houy (LG29), Schnurr (LY9), Lagos (LG20), Holliday (LG22), Perez (LG17), and Park (LY11).
- Event #23:** Klebold is seen walking on the north side of the library (south of the main counter) moving in an easterly direction. Klebold continues moving east, stopping near the entrance to the library (north of display case). Klebold then fires the Tech9 into the display case. Observed by Greenwood (LG11), Kintgen (LY8), Lapp (LG31), Welsh (LG33) and Perez (LG17).
- Event #24:** Klebold moves back around the display case and fires one double barrel shotgun round (pellets) under table #1 hitting Kintgen. Observed by Kintgen (LY8), Blair (LG18) and Kreutz (LY10).
- Event #25:** Klebold steps east towards table #2 and fires one double barrel shotgun round (pellets) under that same table hitting Schnurr and Kreutz. Observed by Kreutz (LY10), Jacobson (LG19), Schnurr (LY9) and Blair (LG18).
- Event #26:** Klebold walks south along the west side of table #2 firing multiple rounds (rapid fashion) with the Tech9 under that same table hitting Townsend. Observed by Blair (LG18) and Perez (LG17).
- Event #27:** Harris seen entering the east section of the library (near table #3) from a pathway between the book shelves. Observed by Jacobson (LG19).

- Event #28:** Klebold moves west of table #3 near Harris after which one of the suspects looks under that same table and states, "Pathetic." Observed by Jacobson (LG19) and Blair (LG18).
- Event #29:** Klebold and Harris move south to table #5 where reloading occurred and one of the suspects then taunts Schnurr regarding God. Observed by Ball (LG23), Schnurr (LY9), Jacobson (LG19), Blair (LG18), Savage (LG25), Holliday (LG22), Kintgen (LY8), Nielson (LY1), Scott (LG15), Lapp (LG31), Todd (LY2), Elmore (LG26), Nowlen (LY12), Welsh (LG33), Bollerud (LG32), Kreutz (LY10), Park (LY11), and Steepleton (LY5).
- Event #30:** Harris steps east towards table #6 and points the pump action shotgun under that table firing twice (pellets) hitting Nowlen and Tomlin. Observed by Nowlen (LY12).
- Event #31:** Klebold moves south/east past table #6 and stands near Tomlin (now lying east of table #6) where he then shoots Tomlin four times with the Tech9. Observed by Nowlen (LY12).
- Event #32:** Harris moves northeast of table #6 and shoots Fleming once with the pump action shotgun (pellets). From the east side of table #4, Harris fires the pump action shotgun under table #2 hitting Townsend, Park, and Kreutz with pellets. Observed by Savage (LG25), Blair (LG18), Kreutz (LY10), Schnurr (LY9) and Park (LY11) and Perez (LG17).
- Event #33:** Harris goes to the south library windows and looks out into the south parking lot (damaging the blinds, identified as W15 on the diagram). Observed by Jacobson (LG19), Elmore (LG26) and Lagos (LG20).
- Event #34:** Klebold and Harris pass through the east side book shelves into the center section. Both suspects stand near table #13 where reloading occurs. Observed by Holiday (LG22), Ball (LG23), Doyle (LY13), Eubanks (LY14), Lagos (LG20), Huntington (LG22), Savage (LG25), Lapp (LG31), Welsh (LG33), and Woodman (LG28).
- Event #35:** Harris walks north to the south computer table to gain access to the blue backpack reportedly containing ammunition. Harris then returns to the area near tables #11 and #13. Observed by Savage (LG25), Parker (LG27), Welsh (LG33), and Johnson (LG16).
- Event #36:** Harris asks the student under table #11 to identify himself. The student identified himself as John Savage. Harris moves north of table #11 as Klebold contacts Savage. Klebold eventually tells Savage to leave the library, which he does. Observed by Savage (LG25), Eubanks (LY14), Ball (LG23), Doyle (LY13), Huntington (LG21), Holiday (LG22), Greenwood (LG11), Lapp (LG31), Elmore (LG26), Parker (LG27), Woodman (LG28),

Bollerud (LG32), Houy (LG30), Perez (LG17), Lagos (LG20), and Hall (LY6).

- Event #37:** While standing north of table #11 Harris shoots Mauser twice with the high point rifle. Mauser is located under table #9. Observed by Blair (LG18), Jacobson (LG19), Lapp (LG31), Elmore (LG26) and Parker (LG27).
- Event #38:** Harris and Klebold move to the south (towards table #14). Klebold fires at least one round (with the Tech9) under that table hitting DePooter. Harris then fires at least two rounds (with the high point carbine rifle) under the same table hitting DePooter and Doyle. A fourth 9 mm round was fired under table #14 hitting Eubanks. The origin of that round cannot be determined. Observed by Eubanks (LY14), Ball (LG23), Parker (LG27) and Doyle (LY13).
- Event #39:** Klebold and Harris move north in the center section and are seen on the east side of table #7. Klebold and Harris then proceed to the southeast corner of the far south computer table. Observed by Lapp (LG31) and Welsh (LG33).
- Event #40:** Harris is seen in the west section of the library throwing a device containing an orange liquid toward the south. Observed by Welsh (LG33).
- Event #41:** Klebold walks around behind the main counter from the west, while Harris walks around the counter from the east. Observed by Lapp (LG31), Todd (LY2), Fair (LG9), and Nielson (LY1).
- Event #42:** Klebold confronts and threatens Todd who now was hiding behind the main counter. Observed by Todd (LY2), Nielsen (LY1) and Greenwood (LG11).
- Event #43:** The investigation shows Klebold shoots back into the "kitchen" area of the library with the Tech9 hitting the TV.
- Event #44:** Klebold and Harris discuss leaving the library and going to the "Commons." Prior to leaving, Klebold slams a chair down on a computer located on the main counter. Observed by Todd (LY2), Nielsen (LY1) and Jacobson (LG19).
- Event #45:** Klebold and Harris leave the library. Observed by Todd (LY2), Nielsen (LY1), Jacobson (LG19) and Schnurr (LY9).
- Event #46:** Most victims and witnesses begin to leave the library exiting out the north door.
- Event #47:** Nielson crawls into the break room and hides in a cupboard. Ireland, who is seriously injured, crawls from Table #15 to the west windows. Ireland pulls himself up and falls out the window into the hands of SWAT.

**Event #48:** Weld and Kean were hidden in the television studio. Dodd was hidden in the Periodicals Room. Nielson was hidden in the break room. Kreutz laid seriously injured under table #2. All the above remained in the library until they were evacuated by SWAT. SWAT discovered the bodies of Dylan Klebold and Eric Harris near the bookshelves in the southwest corner of the library.
