Sir:

On 042099 at 1405 hrs., myself and Det. M. Woodward, 75066, were dispatched to Leawood and Pierce St., to the Denver Police command post. Upon arrival at 1512 hrs., Lt. Maney assigned us to go to Leawood Ele. Sch. and interview students taken from the school.

At 1521 hrs., I was contacted by Tom and Jane Adorney, 730-1194. They stated that their son, Peter Ball, who was at home now, was in the library when the attack started. Their son told them that he saw some of the suspects, but was able to run out the exit and get home. Ball was never contacted by this detective.

At 1530 hrs., I contacted Justin Alber, 103183, 979-4187. He stated that he was eating lunch when the shooting started. He stated that he ran to the science room. The witness stated that he saw someone standing over another student with a sawed off shotgun. He saw this person point it at the party down and fire. Alber completed a written statement.

At 1541 hrs., I contacted Barbara Schneider, 103181, 972-2730. She stated that she was in the Choir room and someone came running into the class and said that there was someone downstairs with a gun. This class was just above the cafeteria. They all barricaded the doors and she never saw any of the suspects. She stated that she heard shots and one large "bang" below them.

At 1546 hrs., I contacted Sara Lammers, 080184, 979-8747. She stated that she was in the science room and heard shots. She went to run, but Mrs. Miller told them to go back inside the class. She said that she stayed in the room and never saw anyone hurt. Just heard the shots.

At 1549 hrs., I contacted Sara Arbogast, 011581, 932-8848. She stated that she was in Chemistry class with Mr. Manuello in the Physics storage room. They barricaded the doors and stayed in the room.

At 1559 hrs., I contacted Jennifer Smull, 071183, 794-4136. She stated that she was in the science room when she heard shots. She stated that an alarm went off and a teacher wearing an orange and yellow shirt told them to get back in class. They locked the doors and flipped the tables p for barricades. She was looking through a crack to see if anyone was

coming. She stated that she saw a party she has seen in school before with a sawed off shotgun. This party was tall, skinny, shoulder length brn hair, black shirt, pants and baseball hat (on backwards), was trying to get into a class next door, but didn't try to get into theirs. She then saw smoke, but didn't know what it was from. Afterwards, a SWAT team found them. She completed a more detailed statement.

At approximately 1730 hrs., we were dismissed from the scene.

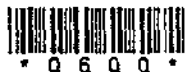





We called Ms. Brim and advised her that we had located a crossbox and were going to make our cut in's to telephone lines. As we made the cut ins, we obtained the telephone numbers of each and these we gave each number to Ms. Brim so we could list each and notify the users that we had taken control of those lines. Ms. Brim later faxed the listed users for each telephone line to the DPD command post along with all the telephone numbers to the Columbine High School. We gave these list to Detective Dave Metzler.



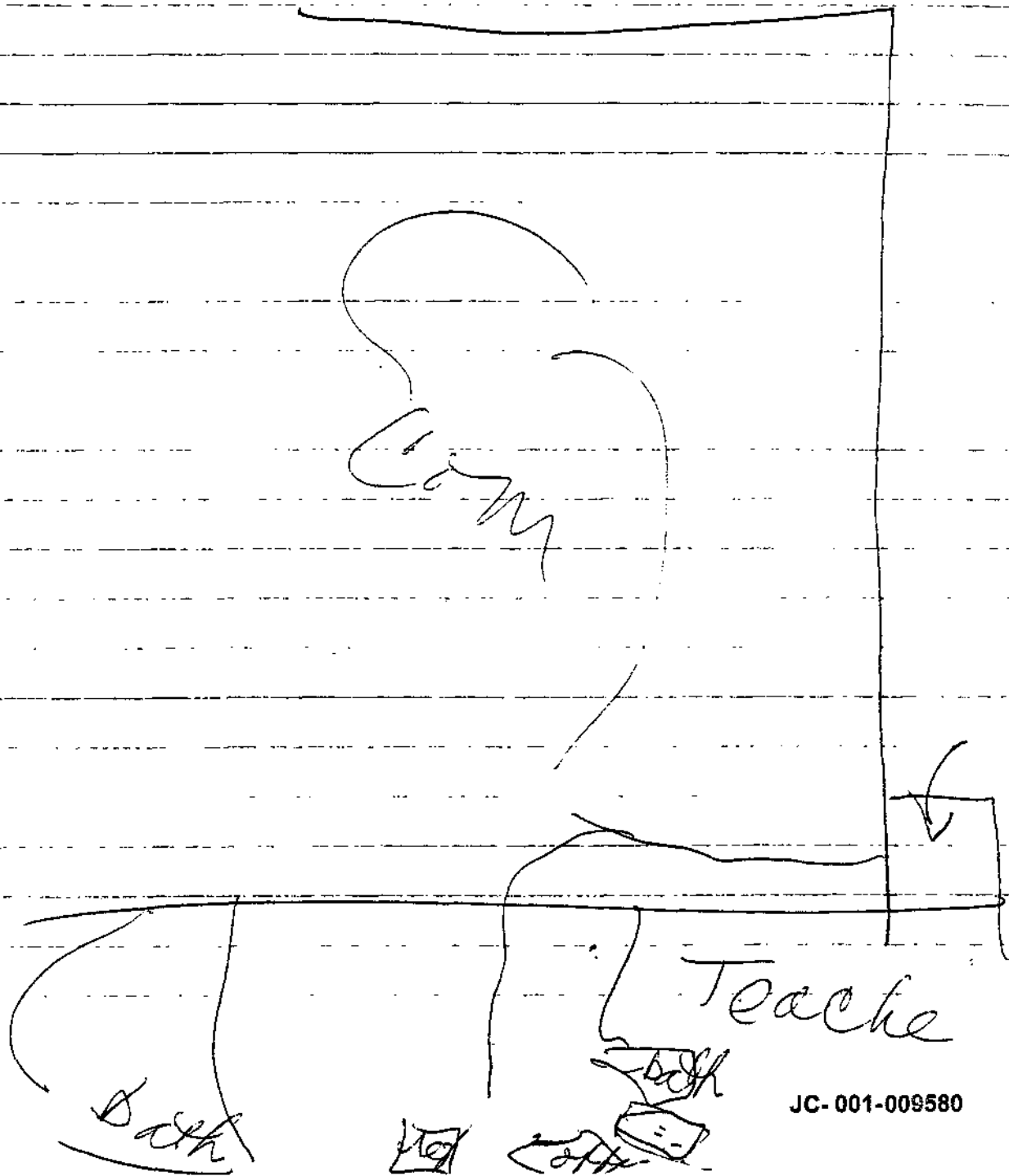

Barnhill, who had gone to headquarters to collect equipment and were en route to the scene, and Detective D. Gabel who was also on the way to the school. I contacted Captain M. O'Neill and advised him that I was at the scene and that Detectives Rich, Barnhill and Gabel were on the way. I also contacted a Jefferson County Sheriff's Department Lieutenant at the Jeffco command post and advised him what resources we had available.

At around 12:30 PM I was asked to help in interviewing a witness. I assisted a female Littleton Police Department detective in interviewing a school secretary who had been in the main office when the gunmen entered the school. I also contacted other school employees who told me of an inter-school radio system to which the suspects might have access. I obtained one of the school radios from a school employee and gave it to Detective Barnhill asking him to monitor the frequency for any indication that the suspects had access to or were using the system. I also instructed the school personnel not to use the system because of the potential for compromising tactical planning.


Sometime shortly after 1:00 PM the other technical investigators and I were asked to provide wireline phone service to the Arapahoe County Sheriff's Department and Denver Police Department command vehicles at the scene. Detective Rich located a telephone pedestal in the back yard of a house on the southeast corner of West Leawood Avenue and South Pierce Street. I began locating and identifying working "pairs" in that pedestal and, as I did so, disconnecting the subscriber side of each loop and connecting the line to the temporary cabling we ran to the command post vehicles. I

also identified the telephone number of each line I had commandeered and called those in to Ms. Lori Brim of US West Security. While myself and the other technical investigators were working on the phone lines, a US West technician arrived at the scene and assisted us in what we were doing.

Once there was no longer a need for the commandeered telephone lines, we disconnected them from the police vehicles and restored service to the subscribers we had interrupted. At about 6:00 PM, after it was determined that there would be no further need for technical surveillance, myself and the other technical investigators were released from the scene.


